Additional information: These sandals date from the 1920s and were collected near San Diego from local Native Americans by Edward Davis. They are made from very fine yucca fibers obtained by processing the leaves. Agave leaves are also processed in this region to make fine fibers for weaving. Microscopy is needed to distinguish yucca and agave fibers. Bundles of many of these fine fibers are used to make the wefts and they appear to be wrapped two bundles at a time around the warps. The warps are essentially cordage, probably twisted into strands by rubbing on a piece of leather on the thigh. The two warps are essentially 2-ply Z-twist cordage probably made of Yucca fibers.
