The paper was first decorated and then cut into thin strips and spun into cord. These were the wefts and were twined around pre-spun habu paper linen yarn. The sole is solid, made of layers of paper, with a painted design called meioses hitoe. Donna Crispin is a fiber artist of Japanese-American ancestry. She lives and works in Eugene, OR.
