Overall sole shape: Symmetrical

Additional information: The overall design is the same as Korea 2 but coarser straw was used. The sole wefts were one, two, and three ply simply combined, not twisted. The vamp consists of wefts extended and S-twisted to form cords that end in small loops. We considered that 8 of these constituted one set of side toe loops and 2 loops constituted a set of front toe loops. The sets are symmetrically positioned and the sandal has an open toe at front.
