Additional information: This sandal was found in Cottonwood Wash, Utah in 1892 by Ben and Hiram Perkins et al. It exhibited at the World's Fair in Chicago. The sandal is plaited with a thick layer of yucca padding on top of the sole that makes it impossible to see the kind of plaiting used.
